Content definition:

Clinical pharmacology is an interdisciplinary field of medicine that uses the knowledge of basic pharmacology and applies it in clinical practice. The field's goals include choosing the right drug and considering the benefit/risk ratio and price aspects. Clinical pharmacology significantly contributes to increasing the safety of pharmacotherapy in risk groups of the population, such as children, the elderly, and pregnant and lactating women. Another goal in this field is the individualization of pharmacotherapy using the methods of pharmacokinetic analysis (therapeutic monitoring of drug levels) and the knowledge of pharmacogenetics. Last but not least, clinical pharmacologists are also engaged in pharmaco-economic analysis, which allows more expensive drugs to be preferred if they are more effective and safer than their cheaper alternatives.
