It provides preventive, diagnostic, therapeutic, assessment, expert, and advisory care for the musculoskeletal system in all age categories. The department also focuses on research in orthopaedics, paediatric orthopaedics, spondylosurgery, onco-orthopaedics and orthopaedic prosthetics, and in the areas of rheumatology and traumatology of the musculoskeletal system.
