Content definition: Roentgenology and radiology investigate disease states using imaging with various forms of energy. It also includes radiological imaging, the so-called interventional radiology, associated with medical treatment. Diagnostic images are obtained by various procedures and with the use of various energies: ionising radiation (X-ray imaging, X-ray fluoroscopy, computed tomography), mechanical energy (ultrasound), electromagnetic waves (magnetic resonance), as well as hybrid methods and other types of well-known and gradually introduced into practice imaging methods. By analysing radiomic signs, radiology ensures timely non-invasive and invasive diagnosis of various disease states, monitoring their dynamics over time, assessing the effect of personalised treatment, and predicting the patient's prognosis. Radiology plays an irreplaceable role in targeted prevention and early diagnosis of oncological diseases, thus reducing mortality. It has an interdisciplinary character, with the possibility of applying the methods of artificial intelligence, radiomics and radiogenomics for further processing and interpretation of image digital medical information
