Urology is an essential medical discipline that deals with the diagnosis, treatment, dispensation, prevention and research of surgical diseases, congenital malformations and injuries of the kidneys and urinary system in men and women, and diseases of the male genital organs. The content of urology also includes the issue of kidney removal and transplantation and the issue of some endocrine and metabolic diseases that have an anatomical or functional relationship with the urogenital system in patients of all ages.
